#### **EXPERIENCE**

- Represented the owner of a small retail rental property in an urban block being assembled for redevelopment. Client did not want to sell and incur capital gains taxes, but was interested in ending up with rentable commercial space in the new project. Over the course of a year, David negotiated and prepared a long-term ground lease of the client's land to the developer, providing the developer an option to create a commercial condominium unit within the development and swap the new unit for the client's land as a tax-deferred exchange.

This included the allocation of contract responsibilities for the infrastructure construction, satisfaction of proffer conditions,
